Foreword

This standard replaces GB/T 13384—1992, General specifications for packaging of mechanical and electrical products, and GB/T 15464—1995, General-purpose specification for the packaging of instrumentation products.

There have been some changes in this national standard over the GB/T 13384—1992 and GB/T 15464—1995 in the following aspects:

- general is changed to the basic requirements;

- incorporate the contents related to the manner of packing and method of protection packing;

- define the reference standards for selection of wood and allowable defects of all parts of wood; modify the requirement for moisture content; add the requirement for wood fumigation;

- add the requirements for manner of strengthening packing case of other materials;

- define the reference standards for the protection packing; simplify the standard contents;

- define the reference standards for the test items; cancel the test items selected concretely; simplify the standard.

This standard is under the jurisdiction of National Technical Committee of Standardization for Packing (SAC/TC 49).
