# **Beach umbrella**

## 1 Scope

This standard specifies terms and definitions, product classification, requirements, test methods, rules of inspection, and Labeling, packaging, transportation, and storage for beach umbrella.

This standard applies to manually operated beach umbrella with cloth and umbrella stand made of different materials.

This standard is not applicable to mechanical and motorized beach umbrella.

## 3 Terms and definitions

For the purposes of this standard, the following terms and definitions apply.

3.1

## beach umbrella

an umbrella may be fixed for use at different sites.

3.2

## directional

the angle of the umbrella stand may not be adjustable

3.3

## direction changeable

the angle of the umbrella stand may be adjustable

## 4 Classification

- 4.1 By structure of shaft, an umbrella may be straight-shaft or folding.
- 4.2 By structure of umbrella, an umbrella may be directional or direction changeable.

## **5** Requirements

## 5.1 Appearance

5.1.1 An umbrella shall be clean and free of stain and rusting marking in appearance.

5.1.2 The electroplated and spray-coated pieces shall be free of peeling, burr, shrinking, rusting, blistering, and grin.

5.1.3 The plastic pieces shall be free of peeling, burr, shrinking, and blistering.

## 5.2 Sewing

The seam of the umbrella cover shall not be separated and edge-exposed and shall be free of such defects as skipping, and broken stitches. There shall not be less than 13 needles within 50 mm of needle pitch density. The misalignment of pattern shall not exceed 8 mm on an umbrella cover not more than 1 m; not exceed 12 mm on an umbrella cover more than 1 m.

## 5.3 Umbrella cover

The umbrella cover shall be free of hole. There shall not be more than 2 locations of total floating, broken warp, and broken woof in the same triangular piece on the textile fabric. On the same umbrella, there shall not be more than 5 locations of total floating, broken warp, and broken woof.

## 5.4 Blocking resistance of umbrella cover
