Foreword

Clause 4 of this Standard is mandatory, the rest are recommendatory.

This Standard is identical to ISO 13857: 2008 Safety of machinery — Safety distances to prevent hazard zones being reached by upper and lower limbs (English Version).

This Standard is equivalent to translation of ISO 13857:2008. In order to be convenient for use, this Standard also made the following editorial amendment:

- Changed the word "the International Standard" to "this Standard";
- Use decimal point "." to replace commas "," which used as decimal point;
- Modified Reference Standard Introduction according to GB/T1.1-2000, and modified international and foreign standards have been referenced and translated into national standards to corresponding national standards.
- Deleted the international standard foreword, re-prepare the foreword;
- "(See Table 4)" in 4.2.3 of ISO13857:2008 is wrong, and has been deleted in this Standard.

This Standard combined and revised GB12265.1-1997 and GB12265.2-2000.

This Standard has the following several differences with GB12265.1-1997 and GB12265.2-2000:

- Full text mandatory is replaced by provisions mandatory for the nature of the standard;
- Added the assumption of "Existing Certain Contact with The Base Level When Wearing Shoes" in 4.1.1;
- Added some descriptions of safety requirements such as 4.2 and 4.3
- Added annex A and bibliography.

Annex A and B of this Standard are informative annex.
