Part 3: Containers for plasma

1 Scope

This part of YY 0326 specifies the requirements for containers for plasma used with hemostix specified in YY 0328, Plasma tubing specified in YY 0326.2 and plasma centrifuge bowl specified in YY 0326.1. The plasma collected and stored in containers for plasma specified in this part is used to prepare blood products, which cannot be used for clinical blood transfusion.
