#### 0. Introduction

Implementing Rules on Compulsory Products of Automobile door lock and door retention components (hereinafter referred to as the Implementing Rules) is compiled based on the requirements of "Implementation Practice of Compulsory Products: Automobile door lock and door retention components" (CNCA-C11-10:2014) (hereinafter referred to as the Implementing Regulations). The Implementing Rules is used together with the Implementing Regulations as supportive document.

Applicable range of products and certification basis of the Implementing Rules stay the same with the relevant provisions of the Implementing Regulations, and are adjusted in accordance with directory definition, directory adjustment and other announcements issued by the National Certification and Accreditation Administration Commission (hereinafter referred to as the NCAC)

Based on the principles of maintaining effectiveness of product certification, improving product quality, serving certified enterprises and controlling certification risk, etc., in accordance with the provisions of the Implementing Regulations, CQC developed and issued the Certification Implementing Rules. By establishing category management requirements of manufacturers, and considering the category of manufacturers, the Implementing Rules specifies the implementation requirements of certification of vehicle indirect vision field device compulsory products.

#### 0.1 Definition of Terms

0.0.1 Testing with Manufacturers' Premises (Abbreviated as TMP)

Engineer from designated laboratory performs the test using the testing equipment in the laboratory of the factory, and may be assisted by persons assigned by the factory. Test report shall be issued and approved by the related designated laboratory.

0.1.2 Witnessed Manufacturers' Testing (abbreviated as WMT)

Engineer from designated laboratory inspects the testing conditions in the laboratory and witnesses the laboratory using its own equipment to perform all the tests or for the submitted test plans, witnesses some of the testing conditions and test items. Inspectors of the laboratory are supposed to submit the original test record, and draft test report according to specified forms together with the designated witnessing engineer. The test report shall be approved and issued by the relevant designated laboratory.

#### 0.2 Category Management Requirements of Manufacturing Enterprises

The CQC collects and collates all kinds of quality information related to the certified products and the manufacturing enterprises, and hereby classifies the manufacturing enterprises. The certification principals, producers (manufacturers) and manufacturing enterprises shall cooperate.

The CQC classifies manufacturing enterprises into four categories, respectively shown with A, B, C and D.

Quality information for manufacturer classification shall at least include the following aspects:

(1)results of factory inspection (including the initial factory inspection and trail inspection after getting the certificate);

(2) results of sample test and / or supervision sampling test (including type test, production site sampling or market sampling, etc.);

(3)national or provincial quality supervision and inspection results, CCC special supervision and inspection results;

(4)cooperation conditions of certification principals, producers (manufacturers) and manufacturing enterprises for supervision after getting the certificate;

(5)quality information feedback of judicial decision, arbitration of complaint and appeal, media exposure, etc;

(6)quality conditions of the certified products;

(7) other information.
