Foreword

This Standard replaces GB/T 5009.64-1996 Method for Analysis of Hygienic Standard of Rubber Sheet (Ring) for Food Use.

Compared with GB/T 5009.64-1996, this Standard is modified as follow:

According to GB/T 20001.4-2001 *Rules for Drafting Standards-Part 4: Methods of Chemical Analysis*, this Standard modifies the structure of the original standard. This Standard is proposed by and under the jurisdiction of Ministry of Health of the People's Republic of China.

The responsible drafting organizations of this Standard are Shanghai Sanitation and Antiepidemic Station, Shanghai Rubber Product No. 3 Plant.

This Standard was first issued in 1985, first revised in 1996 and this is the second revised version.

Method for Analysis of Hygienic Standard of Rubber Sheet (Ring) for Food Use

1 Scope

This Standard specifies the analysis method of various hygienic indexes of rubber sheet (ring) using in food industry produced with natural rubber as the main raw material and fitted with certain auxiliaries.

This Standard applies to the analysis of various hygienic indexes of sheets, rings, etc. for sealing bottled juice beverage, liquor, seasoning and canned food produced with natural rubber as the main raw material and fitted with certain auxiliaries according to special recipe.

3 Sampling Method

Take daily output as a batch number, take 500g evenly from every batch to dry and clean glass bottle, label them, and specify the product name, batch number and date of sampling. Half of them are used for chemical examination, and the other half are stored for two months, and prepare for arbitration analysis.

4 Appearance Inspection and Sensory Indexes

Color and luster are in normal conditions. There is no foreign odor, peculiar
